1. While reasonable care is taken to prevent accidents, injuries, sickness, escape, fire, etc., animals are groomed at the ADALBERTO'S DOGGIES DO-UP at the risk of the owner. In no case shall ADALBERTO'S DOGGIES DO-UP be in any way liable or responsible. The responsibility and/or liability of ADALBERTO'S DOGGIES DO-UP, in no event shall exceed the sum of One Hundred Dollars (\$150.00) and the undersigned agrees to limit the responsibility of ONE Hundred fifty Dollars (\$150.00) and no more, and agrees not to claim any damages against ADALBERTO'S DOGGIES DO-UP of any nature whatsoever either by way of contract, equity, negligence or otherwise, in excess of said sum.

2. In the event of illness or injury, ADALBERTO'S DOGGIES DO-UP will contact your veterinarian. If he or she is not available, ADALBERTO'S DOGGIES DO-UP will use a qualified veterinarian known to ADALBERTO'S DOGGIES DO-UP. The cost of medication and treatment will be at the owner's expense.

3. Unacceptable behavior by pets, resulting in facility damage, injuries to an employee, injuries to another pet, or to itself will be estimated and charged to the owner of pet at time of pickup. Payment of this charge is due before pet will be released to the owner.

**4. The State of New Jersey requires all dogs and cats be vaccinated against rabies. ADALBERTO'S DOGGIES DO-UP requires proof of vaccination for all family pets. The owner is responsible for regular veterinarian checkups and for keeping his or her pet updated on inoculations and healthy. All inoculations must be given ten days prior to grooming at ADALBERTO'S DOGGIES DO-UP.**

5. ADALBERTO'S DOGGIES DO-UP will only release the pet to the owner. If the owner would like someone else to pick up the pet, prior notifications must be made with the ADALBERTO'S DOGGIES DO-UP. For the protection of owner's pet, ADALBERTO'S DOGGIES DO-UP reserves the right to check IDs prior to the pet's release. If the pet is not picked up by closing time, the family pet will be placed in the boarding facilities, at the owner's expense. If there is no available space for your pet, the family pet may be moved to a crate and will be take Care and walked during the day.

6. The owner is responsible for giving ADALBERTO'S DOGGIES DO-UP all information pertaining to his or her family pet. Since lack of information may result in sickness or injury, please be as thorough as possible when giving pet information. The owner also verifies all information given to ADALBERTO'S DOGGIES DO-UP is truthful and complete, by signing below.

7. It is understood by ADALBERTO'S DOGGIES DO-UP and owner that all provisions on this contract shall be binding by both parties, their heirs, administrators, and assigns of the owner of the within named animal. By signing below, the owner understands all of the above and agrees to follow all of ADALBERTO'S DOGGIES DO-UP policies and procedures.

8. The owner understands that ADALBERTO'S DOGGIES DO-UP is designed to groom family pets only. ADALBERTO'S DOGGIES DO-UP is not responsible for any harm if the owner chooses to groom a working pet, show pet, etc. ADALBERTO'S DOGGIES DO-UP will not pay for any damages to a show working etc. pet, either in show losses, in lost breeding rights, or lost income from said pet, etc.

9. By signing below, the owner is aware, condition of coat they are allowed to inspect the premises prior to the pet's stay, and that any and all questions regarding their pet's stay have been answered.

10. The owner of the named pet specifically represents that he/she is the sole owner of the said pet and that there are not now any lien or mortgage against said animal.

11. Any controversy or claim arising out of or relating to this contract shall be settled by arbitration in accordance with the rules set forth by the American Arbitration Association. The arbitrator shall, as part of his award, determine an award to the prevailing part of the cost of such arbitration reasonable attorney's fees of the prevailing party.
